## **Resources for Bucks County Residents**

## **IMPORTANT UPDATE SEPTEMBER 2020**

The CDC has ordered a temporary halt to evictions (for non-payment of rent only) until December 31st, 2020 if you meet certain criteria including:

- 1) You've made best efforts to obtain government assistance for rent
- 2) You meet certain income requirements
- 3) You are unable to pay the full rent due to loss of household income
- 4) You have made best efforts to make timely partial payments that are as close to full payment as circumstances may permit

### Contacting Housing Link can help you meet requirement #1 above—do so immediately!

- If you have not yet received a notice of eviction, completing the <u>declaration</u> below and providing it to your landlord stops the filing of an eviction (if the eviction is for non-payment of rent)
- If you have received a notice of eviction, filling out this declaration could stop the process from moving forward
- If you are having trouble paying your rent, call the Housing Link as soon as possible to be connected to a Housing Coach that can determine eligibility for rental assistance
